THIS INDENTURE is made on this the 13th day of

March, Two Thousand ;

BETWEEN

1. SMT. GESTA DEVI JALAN, Wife of Late Ganesh Prasad Jalen, resident of Vasant Vihar, Kanke Road, Ranchi, in the state of Bihar, hereinafter called the "SETTLOR".

(The expression "SETTLOR" shall unless excluded by or repugnant to the context be deemed to include his heirs, successors, executors, administrators, representatives and assigns.)

AND

1. SRI NARAYAN PRASAD JALAN, son of Late Ganesh Prasad Jalen, resident of Vasant Vihar, Kanke Road, Ranchi in the state of Bihar, hereinafter called the "TRUSTEE" of the first part ;

2. SRI MURARI LAL JALAN, Son of Late Ganesh Prasad Jalan, resident of Vasant Vihar, Kanke Road, Ranchi in the State of Bihar, hereinafter called as "TRUSTEE" of the Second Part ;

3. SRI VISHAL JALAN, Son of Late Ganesh Prasad Jalan, resident of Vasant Vihar, Kanke Road, Ranchi in the State of Bihar, hereinafter called the "TRUSTEE" of the Third Part ; AND

4. SMT. GEETA DEVI JALAN, wife of Late Ganesh Prasad Jalan, resident of Vasant Vihar, Kanke Road, Ranchi in the State of Bihar, hereinafter called "TRUSTEE" of the Fourth Part ;

(The expressions, "TRUSTEE" of the First Part, Second Part, Third Part and Fourth Part shall unless excluded by or repugnant to the context be deemed to include their respective heirs, successors, executors, administrators, representatives and assigns.)

WHEREAS the SETTLOR of the TRUST is desirous of setting a Trust and creating a Public Charitable Trust and for such purposes the SETTLOR has made over to the TRUSTEES an initial contribution of Rs.11,000/- (Rupees eleven thousand only) in cash ;

AND WHEREAS the TRUSTEES named above are willing at the request of the "SETTLOR" to be vested with the property i.e. Rs.11,000/- (Rupees eleven thousand only) for the purpose of carrying out the objects of the SETTLOR of the TRUST ;

NOW THIS INDENTURE WITNESSETH that the SETTLOR of the TRUST has transferred and assigned to the TRUSTEES above mentioned sum of Rs.11,000/- (Rupees eleven thousand only) to HAVE AND HOLD the same in Trust for the objects of the Trust as described below to be used and appropriated by the Trustees in order to carry on and fulfil the object of the Trust in accordance with the directions of the SETTLOR so far as the same shall extend and the SETTLOR hereby

~~Relinquishment~~ for all time any claim to or interest in the aforesaid sum of Rs.11,000/- (Rupees eleven thousand only) and assets to be acquired hereafter (hereinafter called collectively the subject matter of the Trust) ;

AND NOW THE SETTLOR OF THE TRUST hereto deem it necessary to reduce to writing the terms and conditions for the purpose of carrying out the object of the SETTLOR of the Trust as stated hereinbefore and set forth directions hereunder so as to enable the TRUSTEES to prosecute its objects according to the wishes and directions of the " SETTLOR" of the TRUST.

NOW THIS INDENTURE WITNESSES AND THE PARTIES HERETO HEREBY BIND THEMSELVES AS HEREUNDER : -

1. That the SETTLOR of the Trust hereby convey, transfer and assign to the Trustees the above mentioned sum of Rs.11,000/- (Rupees eleven thousand only) to HAVE AND HOLD the same in the Trust for the objects of the Trust as described below to be used and appropriated by the Trustees in order to carry on and fulfil the objects of the Trust in accordance with the directions of the SETTLOR so far as the same is possible and the SETTLOR hereby relinquish for all type or any claim to or interest in the aforesaid sum of Rs.11,000/- (Rupees eleven thousand only) and assets to be acquired hereafter (hereinafter called collectively the subject matter of the Trust).

2. The name of the Trust shall be " GANESH PRASAD JALAN MEMORIAL TRUST".

3. The office of the Trust shall be located at Vasant Vihar, Kanke Road, Ranchi and any branch or branches may be opened at any place or places under such name or names as the Trustees hereto may agree and decide from time to time.

4. That the income from the Trust fund will be utilised in India for the relief of the poor, education, medical relief and advancement or any other objects of general public utility not involving the carrying of any activity for profits.

5. That the objects of the Trust are as follows :-

- (i) to establish, start and/or run educational institution or any other institutions, Maternity Home, Hospital, old age Home etc. in the name of the Trust or in any other name or names ;
- (ii) to manage and administer school, college and other institutions for the advancement of the social, religious, educational and/or cultural well being of the people irrespective of their religion, caste, creed and/or social status ;
- (iii) to provide food, clothing and/or shelter to poor persons, orphans, destitutes, aged old person etc. and to give aids to them either in cash or kind or otherwise;
- (iv) to grant aid to poor widows and orphans ;
- (v) to distribute medicines and other medical facilities within the hospital/nurshing homes or otherwise ;
- (vi) to arrange for medical and surgical treatment including payment or expenses in India for medical and surgical treatment to poor and needy persons. ;
- (vii) to grant and give aid to poor and needy students and scholars ;
- (viii) to establish, maintain, support and grant aid to all or any kinds of Ashrams, Maths, Mahila Ashrams, Anathalayas etc. meant for helping and/or accomodating poor and needy people ;

- (ix) to establish, maintain, support and grant aid to schools, colleges, hostels, libraries, reading rooms and other educational institutions ;
- (x) to provide funds for the performance of marriage of poor and needy boys and girls ;
- (xi) to dig and make provisions for wells, pumps and water supply ;
- (xii) to construct, maintain and run Dharamshalas/ Atithi Griha ;
- (xiii) to provide and institute programme for the rehabilitation of patients and handicapped people ;
- (xiv) to provide funds for the constructions, renovation and repairs of any temple, mosque, gurudwara or church and for renovation and repairs of any temple, mosque, gurudwara, church or other place of historic, archaeological and artistic importance or a place of public worship or renown ;
- (xv) to take over, observe or associate with any other society or association or institutions whose objects are similar to the object of the Trust ;
- (xvi) to construct, maintain, alter or improve the building and premises that may be acquired by the Trust ;
- (xvii) to invest, dispose of, transfer and otherwise deal with the subject matter of the Trust in such a manner that the Trustee would deem fit and proper and acquire other properties and assets to enable them to carry on the objects of the Trust effectively. ;
- (xviii) to acquire by purchase, take on lease, hire or by gift or otherwise and hold any movable or immovable and also any immovable property or properties or any rights or privileges that may be deemed necessary or useful for the advancement of the object/objects of the Trust or any of them .

(xix) The Trust may at any time invite and receive or without such invitation receive any voluntary contribution from the Trustees or member of the public. The Trustees may allow any such donor to construct a building or a part of its on any land belonging to the Trust for the purpose of charities. Any such donation may be accepted either with or without any special conditions as may be agreed upon between the donor and the Trustees provided that such conditions are not inconsistent with the intents and purposes of the Trust ;

(xx) to do all such other lawful acts, deeds and things which are incidental and conducive to the attainment of the objects or any of them ;

(xxi) to apply the income and properties of the Trust for the fulfilment of its objects and not to pay any portion thereof by way of profits, dividend or bonus to any member of the Trust or any person claiming through any of the members. PROVIDED THAT nothing hereto contain shall prevent the payment in good faith or remuneration or reward or travel expenses or incidental charges to any officer, employees or servant of the Trust or any member of the Trust or other person in return for any service actually rendered to the Trust ;

(xxii) And generally, act in furtherance of the objects of the Trust and for similar or allied to the aforesaid objects ;

6. That the management and control of GANESH PRASAD JALAN MEMORIAL TRUST, Ranchi and/or of the branches of the Trust shall be in the hands of the Board of the Trustees. The Board of the Trustees may form committees/sub committees and make rules, regulations and/or by-laws from time to time to control and regulate the proper working to achieve and carry on the purpose of objects of the Trust.

7. The Trustee shall hold office during his life time or till she or he retires or becomes insolvent as the case may be.

8. Trustees shall as soon as possible shall cause the 'Trust' to be registered under the societies Registration Act.

9. That the Trustees shall keep proper accounts of all receipts and expenditure and the same shall be audited and circulated to all the members of the Trustees.

10. That as long as the SETTLOR of the Trust shall like and be able to act in the matter, she shall remain the Trustee of the Trust and she individually shall have a casting vote also.

11. That the Bank Account shall be opened in any schedule Bank by the Trustees and will be operated by signatories of at least two Trustees who are duly authorised by Resolution of the Board of Trustees. That after debiting all the necessary expenses incurred in the realisation of the income of the subject matter of the Trust, the balance of the income shall be deposited in a schedule Bank being kept as reserved fund to be utilised in accordance with the decision of the Trustees expressed in a joint meeting of the Trustees or any circulation.

12. That the Trustees shall elect one of them to be the President of the Board of the Trustees and such elected President shall be entitled to preside at all meetings of the Trustees unless prevented to do by any rule of law and the President shall also have the casting vote ;

13. The number of Trustees shall not be less than three and more than eleven in general. However, the number of Trustees may be increased with the consent of all the Trustees then in Board of the Trustees.

14. The office of the Trustees shall ipsofacto become vacant on the happening of any of the following events :
 - (a) death,
 - (b) insanity,
 - (c) resignation,
 - (d) on being rendered in-capable to perform the duties of Trustees,
 - (e) on being convicted of any serious criminal offence involving moral turpitude.
15. The Trustees will have power to co-opt Trustees and if there be any vacancy in the office of the Trustee for any reason whatsoever, the same may be filled up by the continuing Trustee or Trustees.
16. The Trustees may from time to time frame rules for the conduct of the affairs of the Trust and to regulate the meeting of the Trustees. In the absence of such regulations all the matters will be decided by the majority.
17. Resolution passed without any meeting of the Trustees and evidenced in writing and signed by at least two of the Trustees or majority of the Trustees, as the case may be, shall be valid and effectual as by a resolution duly passed at a meeting of the Trustees.
18. The Trustees shall be competent in their absolute discretion to transfer and assign the Trust Fund/ property to any recognised Trust, society or institutions having charitable objects for the purpose of administering the Trust fund.
19. It is expressly declared that no part of the Trust property or its income shall be applied for any purpose which is not a public charitable purpose.
20. The Trustees have agreed to accept this Trust and to be vested with the ownership and possession of the subject of the Trust.
